**SOLICITORS AND PEDDLERS RULES OF CONDUCT**

A Permittee shall carry his/her Permit and Identification Badge at all times and exhibit it as required by the Ordinance.

A Permittee shall not permit any other person to have possession on his/her Permit and/or Identification Badge and shall immediately report its loss to the City's Police Department. A Permittee shall not cause or allow his/her Permit and/or Identification Badge to be altered or defaced.

A Permittee shall not enter or attempt to enter any dwelling house without invitation or permission of the occupant and shall immediately leave any premises upon request.

A Permittee shall not represent to anyone that the issuance of a Permit and/or Identification Badge by the City is an endorsement by the City of (i) the Permittee, (ii) the Permittee's goods or services, (iii) or of the goods or services of Permittee's principal employer.

A Permittee shall immediately surrender Permittee's Permit or Identification Badge upon revocation of such Permit and Identification Badge as hereinafter provided.

A Permittee shall Peddle, Solicit, or distribute merchandise only between the hours of 9:00 a.m. and 6:00 p.m. or sundown, whichever is earliest, Monday through Saturday unless specifically invited to a house by the occupant or pursuant to an appointment.

A Permittee shall comply with notices bearing the words "No Peddlers, " "No Solicitors," or words of similar restriction on any private residential property in the City.

**ORDINANCE NO. 16-2301**

***An ordinance of the City of Hoover to amend Chapter 8, Licenses and Business Regulations of the Municipal Code of the City of Hoover, Alabama***

WHEREAS, the citizens of Hoover have the right to be secure from unwanted intrusion into their privacy and from criminal or fraudulent conduct or activity; and

WHEREAS, solicitation at a residence directly implicates the security of citizens of this City and City officials have received and are aware of citizen complaints about certain practices or conduct associated with solicitation within this City, including but not limited to fraud; and

WHEREAS, the City Council is aware of criminal activity in this City as well as other cities as a result of solicitors gaining access to residences under the guise of soliciting; and

WHEREAS, the City Council recognizes that there are constitutional guarantees associated with the practice of soliciting which are to be respected and safeguarded; and

WHEREAS, the City Council wishes to adopt police power regulations which are designed to protect the security of citizens in their lives, their homes, and their property, and which do not offend constitutional guarantees.

NOW, THEREFORE BE IT ORDAINED by the City Council of the City of Hoover, in regular meeting duly assembled, a quorum being present, as follows:

**Section 1. CHAPTER 8 – ADDITIONS THERETO.** Chapter 8, LICENSES AND BUSINESS REGULATIONS of the *Municipal Code of the City of Hoover, Alabama* is hereby amended by adding the following Article XIII to this Chapter:

**ARTICLE XIII – Solicitation and Peddling Regulations.**

A. Chapter 8, Article XIII, Section 8-400 of the *Municipal Code of the City of Hoover, Alabama* is hereby amended by adding the following:

**Section 8-400. Purpose; Scope.**

a. *Purpose.*

1. The City Council finds that its citizens have the right to be secure from unwanted intrusion into their privacy and from criminal or fraudulent conduct or activity.
2. The City Council further finds that solicitation at a residence directly implicates the security of citizens of this City and City officials have received and are aware of citizen complaints about certain practices or conduct associated with solicitation within this City, including but not limited to fraud.
3. The City Council is also aware of criminal activity in this City as well as other cities as a result of solicitors gaining access to residences under the guise of soliciting.

4. The City Council recognizes that there are constitutional guarantees associated with the practice of soliciting which are to be respected and safeguarded.
  5. Therefore, the purpose of this article is to adopt police power regulations which are designed to protect the security of citizens in their lives, their homes, and their property, and which do not offend constitutional guarantees.
- b. *Scope.* This article shall have full force and effect throughout the corporate limits of the City and is intended to regulate all forms of solicitation that physically occur at a residence, including, but not limited to, Soliciting, Peddling, and canvassing, as hereinafter defined.

B. Chapter 8, Article XIII, Section 8-401 of the *Municipal Code of the City of Hoover, Alabama* is hereby amended by adding the following:

**Section 8-401. Definitions.**

The following words, terms, and phrases, and their derivations, when used in this Article, shall have the meanings ascribed to them in this Section, except where the context clearly indicates a different meaning.

- a. *Application Documents* means all documentation required by the City to be presented and approved in order to receive a Permit, including but not limited to, an application in writing, photographs, and a criminal background check.
- b. *Canvasser* means any person who goes upon the premises of any private residence in the City, not having been invited by the occupant thereof, and attempts to make personal contact with a resident without prior specific invitation or appointment with the resident, for the primary purpose of (1) attempting to enlist support for or against a particular religion, philosophy, ideology, political party, issue, or candidate, even if incidental to such purpose the canvasser accepts the donation of money for or against such cause, or (2) distributing a handbill or flyer advertising a non-commercial event or service.
- c. *Charitable* means of or relating to the assistance of those in need and includes the words "patriotic," "philanthropic," "social service," "health," "welfare," "benevolent," "educational," "civic," "cultural," "religious" or "fraternal."
- d. *Contributions* mean a gift or payment to a common fund or collection and includes any donations under the guise of a loan or money or property and include the words "alms," "money," "subscription," and "property."
- e. *Department* means the City of Hoover Department of Revenue.
- f. *Director* means the Director of the City of Hoover Department of Revenue or his/her authorized representative.
- g. *Peddler* means any person who goes upon the premises of any private residence in the City, not having been invited by the occupant thereof, carrying or transporting goods, wares, merchandise, or personal property of any nature and offering the same

for sale. This definition also includes any person who solicits orders and as a separate transaction makes deliveries to purchasers as part of the scheme to evade the provisions of this Article. The term "Peddler" does NOT include a person who distributes handbills or flyers for a commercial purpose to advertise an event, activity, good, or service that is offered for purchase at a different location.

- h. *Peddling* (alternatively, *Peddle*) includes all activities ordinarily performed by a Peddler as indicated under paragraph g of this Section.
- i. *Permit* means a document issued by the City evidencing approval to a specific individual to allow the individual to Solicit and Peddle in the City.
- j. *Permittee* means an individual who has been approved for and has received a Permit issued by the Department as provided in this Article allowing such individual to Solicit and/or Peddle within the City of Hoover.
- k. *Person* means a natural person or any firm, corporation, association, club, society, or other organization not otherwise exempted from the provisions of this Article in Section 8-402.
- l. *Solicitor* means any person who goes upon the premises of any private residence in the City, not having been invited by the occupant thereof, for the purpose of taking or attempting to take orders for the sale of goods, merchandise, wares, or other personal property of any nature for future delivery, or for services to be performed in the future. This definition also includes any person who, without invitation, goes upon private property to request contribution of funds or anything of value, or to sell goods or services for non-commercial purposes, unless otherwise exempted by Section 8-402.
- m. *Solicitation* (alternatively, *Solicit*, *Soliciting*) includes all activities ordinarily performed by a Solicitor as indicated under paragraph l of this Section.

C. Chapter 8, Article XIII, Section 8-402 of the *Municipal Code of the City of Hoover, Alabama* is hereby amended by adding the following:

**Section 8-402. Permit Required; Exemptions from Article Requirements.**

Persons engaging in Peddling and/or Solicitation activities within the City must secure a Permit from the Department before engaging in such activities within the City, unless otherwise set forth herein.

It shall be unlawful for any Person who is not the holder of a valid and unexpired Permit issued by the Department pursuant to this Article, to engage in Peddling or Solicitation activities within the City of Hoover.

The following are exempted from the provisions of this Article:

- a. Any Solicitation made upon premises owned or occupied by an organization upon whose behalf the Solicitation is made;

- b. Any communication by an organization Soliciting Contributions solely from members of such organization at the time of such Solicitation;
- c. Any Solicitation in the form of a collection at a regular meeting, assembly, or service of a Charitable entity;
- d. Any Solicitation for the relief of any individual specified by name at the time of the Solicitation where the Solicitor represents in each case that the entire amount collected shall be turned over to the named beneficiary;
- e. Any Solicitation made on behalf of a local affiliate of a nationally recognized charitable or benevolent entity (*e.g.*, Boy Scouts, Girl Scouts, 4-H, etc.);
- f. Any Solicitation made on behalf of an organization or group affiliated with primary, middle, or secondary education; or
- g. A "Canvasser" as defined in Section 8-401(b).

D. Chapter 8, Article XIII, Section 8-403 of the *Municipal Code of the City of Hoover, Alabama* is hereby amended by adding the following:

**Section 8-403. Application Process.**

- a. Any Person, not exempted by Section 8-402 hereof, desiring to obtain a Permit to engage in the activities described in paragraphs (g), (h), (k), and/or (l) of Section 8-401 shall make application therefor, in person, to the Department.
- b. Such application shall be made on a form to be furnished by the Department and shall provide, at a minimum, for the following information and consent:
  - 1. Age, address, and identification of the applicant, to be provided through the applicant's U.S. state issued driver's license, U.S. state issued identification card, U.S. passport, or foreign passport with U.S. Visa certification. ;
  - 2. Place and date of birth and Social Security number;
  - 3. Temporary address (if applicable);
  - 4. Permanent residence address;
  - 5. The address at which notices will be received by applicant under this Article;
  - 6. The name, address, and telephone number of the applicant's employer or principal, if any, and a brief description of the nature of the business activity thereof and credentials in written form establishing the relationship and the authority of the employee or agent to act for the employer or principal, as the case may be;
  - 7. The nature of business or activity in which the applicant wishes to engage within the City;



8. The hours and location for which the right to Peddle or Solicit is desired;
  9. List of any other current or expired Soliciting permits within the last twenty-four (24) months from the City of Hoover or any other entity in the State of Alabama;
  10. Proof of possession of any license or permit which, under federal, state, or local laws or regulations, the applicant is required to have in order to conduct the proposed business, or which, under any such law or regulation, would exempt the applicant from the licensing requirements of this Article;
  11. A statement as to whether the applicant has been convicted in any jurisdiction of any crime other than of minor traffic violations (*e.g.*, felonies, misdemeanors, or ordinance violations); If yes, applicant must provide the nature of the offense or violation, the penalty or punishment imposed, the date when and place where such offense occurred, and any other pertinent details thereof;
  12. A statement authorizing the City to acquire and/or review a full criminal background check on the applicant through a third party selected by the City; and
  13. The applicant's signature.
- c. The applicant shall fully complete the application and, together with the application, submit to the Department (i) such applicant's U.S. state issued driver's license, U.S. state issued identification card, U.S. passport, or foreign passport with U.S. Visa certification and (ii) two (2) passport photographs of the applicant which shall have been taken within sixty (60) days immediately prior to the date of filing of the application. The photographs shall measure two (2) inches by two (2) inches and show the head and shoulders of the applicant in a clear and distinguishing manner. The photographs shall be taken in front of a plain white or off-white background in full-face view directly facing the camera.
  - d. At the time of filing the application with the Department, the applicant shall pay to the Department a non-refundable \$100.00 fee to defray the costs of administering this Article.
  - e. The City is authorized to establish the procedure for obtaining full criminal background checks for applicants. Such full criminal background check shall be at the expense of the applicant. A "full criminal background check" is defined as the obtaining of a consumer report from a nationally-accredited consumer reporting agency ("Agency") that reports the following checks on the applicant: (1) an examination of specified public governmental criminal records maintained within the United States, such as those maintained by county courthouses, federal courthouses, state administrative offices of court, state bureaus of investigation, departments of highway patrol or public safety, or other federal, state or local agencies, (2) an examination of the national sex offender registry maintained by the United States Department of Justice, and (3) an examination of any other criminal record sources deemed necessary by the City. The applicant's Application Documents will not be reviewed until such full criminal background check has been received by the City of Hoover.

- f. Upon receipt of the fully completed Application Documents (including the application, photographs, full criminal background check, and all other required supporting evidence of identification as detailed above), the Director or his/her authorized representative shall review the application.
- g. Upon approval of the Application Documents, there shall be issued to the applicant a Permit and an identification badge. The identification badge shall show the name, address, and photograph of the Permittee and the date of badge expiration. Any denial of a Permit application shall be in accordance with Section 8-404 hereof.

E. Chapter 8, Article XIII, Section 8-404 of the *Municipal Code of the City of Hoover, Alabama* is hereby amended by adding the following:

**Section 8-404. Denial of Permit.**

- a. A Permit, as provided in this Article, may be denied for any of the following reasons:
  - 1. The location and/or time of Solicitation or Peddling would endanger the safety and welfare of the Solicitors, Peddlers, or the citizens of the City;
  - 2. An investigation reveals that the applicant falsified and/or provided inaccurate information on the application;
  - 3. The applicant has been convicted of a felony, misdemeanor, or ordinance violation involving a sex offense, trafficking in controlled substances, or any violent acts against persons or property that reasonably and directly indicate a risk to the public;
  - 4. The applicant is a person against whom a judgment or conviction for, fraud, deceit, or misrepresentation has been levied within ten (10) years prior to the date of the application;
  - 5. The applicant fails to provide proof of possession of any license or permit which, under federal, state, or local law or regulations, the applicant is required to have in order to conduct the proposed business;
  - 6. There is no proof as to the authority of the applicant to serve as an employee/agent to the employer/principal;
  - 7. The applicant has been denied a Permit as provided herein within the three (3) years immediately preceding the date of application, unless the applicant shows to the satisfaction of the Director or the Director's designee that the reasons for such earlier denial no longer exist; or
  - 8. Failure by the applicant to provide all information required by Permit application.
- b. The denial and the reasons for Permit denial shall be noted on the application form, and the applicant shall be notified in writing of the application denial. Notice shall be mailed to the applicant at the address designated for notices pursuant to this Article as shown on the application form.

F. Chapter 8, Article XIII, Section 8-405 of the *Municipal Code of the City of Hoover, Alabama* is hereby amended by adding the following:

**Section 8-405. Permit Expiration.**

All Permits issued pursuant to this Article shall expire four (4) months from the date of issuance.

G. Chapter 8, Article XIII, Section 8-406 of the *Municipal Code of the City of Hoover, Alabama* is hereby amended by adding the following:

**Section 8-406. Identification Badge Exhibition Required.**

At the time the Permit is issued, the Director shall issue to each Permittee a badge, which shall be worn by the Permittee in such a way as to be plainly visible at all times while the Permittee is Soliciting or Peddling in the City.

H. Chapter 8, Article XIII, Section 8-407 of the *Municipal Code of the City of Hoover, Alabama* is hereby amended by adding the following:

**Section 8-407. Permit Exhibition Required.**

Every Person required to obtain a Permit under the provisions of this Article shall exhibit the Permit when requested to do so by any prospective customer, citizen, or City employee.

I. Chapter 8, Article XIII, Section 8-408 of the *Municipal Code of the City of Hoover, Alabama* is hereby amended by adding the following:

**Section 8-408. Transfer Prohibited.**

It shall be unlawful for any Person other than the Permittee to use a Permit or wear any identification badge issued pursuant to the provisions of this Article for the purposes of Solicitation and/or Peddling within the City.

J. Chapter 8, Article XIII, Section 8-409 of the *Municipal Code of the City of Hoover, Alabama* is hereby amended by adding the following:

**Section 8-409. Entry upon Premises Unlawful.**

It shall be unlawful for any Person while conducting the business of a Canvasser, Peddler, or Solicitor, to enter upon any residential premises in the City where the owner, occupant, or person legally in charge of the premises has posted, at the entry to the premises or at the entry to the principal building on the premises (including at the entry of a subdivision, apartment complex, or similar areas), a sign bearing the words "No Peddlers," "No Solicitors," or words of similar restriction.

K. Chapter 8, Article XIII, Section 8-410 of the *Municipal Code of the City of Hoover, Alabama* is hereby amended by adding the following:

**Section 8-410. Hours of Solicitation.**

No Person, while conducting the activities of a Peddler or Solicitor, shall enter upon any private property, knock on doors, or otherwise disturb persons in their residences between the hours of 6:00 p.m. or sundown, whichever is earliest, and 9:00 a.m. Further, no Peddling or Soliciting may occur on Sundays.

L. Chapter 8, Article XIII, Section 8-411 of the *Municipal Code of the City of Hoover, Alabama* is hereby amended by adding the following:

**Section 8-411. Rules of Conduct.**

Every Person to whom a Permit has been issued hereunder shall, in the carrying on of the Person's business or activities in the City, comply with the following rules of conduct, which shall be provided to the Permittee upon approval of the Permittee's Application Documents:

- a. A Permittee shall carry his/her Permit and identification badge at all times and exhibit it as required in Sections 8-406 and/or 8-407 hereof.
- b. A Permittee shall not permit any other person to have possession of his/her Permit and/or identification badge and shall immediately report its loss to the City's Police Department. A Permittee shall not cause or allow his/her Permit and/or identification badge to be altered or defaced.
- c. A Permittee shall not enter or attempt to enter any dwelling house without invitation or permission of the occupant and shall immediately leave any premises upon request.
- d. A Permittee shall not represent to anyone that the issuance of a Permit and/or identification badge by the City is an endorsement by the City of (i) the Permittee, (ii) the Permittee's goods or services, (iii) or of the goods or services of Permittee's principal employer.
- e. A Permittee shall immediately surrender Permittee's Permit or identification badge upon revocation of such Permit and identification badge as hereinafter provided.
- f. A Permittee shall Peddle, Solicit, or distribute merchandise only between the hours of 9:00 a.m. and 6:00 p.m. or sundown, whichever is earliest, Monday through Saturday unless specifically invited to a house by the occupant or pursuant to an appointment with such occupant.
- g. A Permittee shall comply with notices bearing the words "No Peddlers," "No Solicitors," or words of similar restriction on any private residential property in the City.

M. Chapter 8, Article XIII, Section 8-412 of the *Municipal Code of the City of Hoover, Alabama* is hereby amended by adding the following:

**Section 8-412. Permit Revocation.**

- a. The Chief of Police or his/her designee may immediately suspend or revoke any Permit issued under this Article for just cause or in the interest of public safety, for any of the following reasons:
  1. Fraud, misrepresentation, misleading statement, or false statement by the Permittee contained in any Application Document or made to any city employee during the permitting process;
  2. Fraud, misrepresentation, or false statement made by the Permittee in the course of conducting Solicitation or Peddling activities;
  3. Conducting Peddling or Solicitation activities contrary to the provisions contained in the Permit;
  4. Any violation of this Article;
  5. Conviction by Permittee of any crime involving moral turpitude;
  6. Conducting Peddling or Solicitation activities in such a manner as to create a public nuisance, constitute a breach of the peace, or endanger the health, safety, or general welfare of the public;
  7. Any violation by the Permittee of any provision of this Code or any statute of the state relating to the business for which the Permit is issued; or
  8. Violating, aiding or abetting in violating or knowingly permitting or suffering to be violated any penal ordinance of the City or any criminal law of the state.
- b. The conditions hereinabove set forth as grounds for the revocation of a Permit shall also constitute grounds for the City to refuse to renew a Permit.
- c. The decision to revoke or refuse to renew any Permit issued under this Article may be appealed to the Hoover City Council. Any Permittee aggrieved by a Permit revocation or any applicant aggrieved by the refusal to renew a Permit shall file a written notice of appeal with the City Clerk within seven (7) days following revocation of or refusal to renew a Permit. Thereafter, the City Council shall set a time for hearing on the matter of revoking or refusing to renew a Permit. A notice of such hearing shall be given to the applicant/Permittee at least one (1) day before the day set for said hearing. At the hearing, the City Council shall hear all evidence offered by any party and all evidence that may be presented bearing upon the question of revocation or the refusal of renewal, as the case may be.

N. Chapter 8, Article XIII, Section 8-413 of the *Municipal Code of the City of Hoover, Alabama* is hereby amended by adding the following:

**Section 8-413. Claims of Exemption.**

Any person claiming to be legally exempt from the regulations set forth in this Article, or from the payment of a Permit fee, is required to cite to the Director, the Chief of Police,

or their designee(s) the statute or other legal authority under which an exemption is claimed and is required to present to the Director, the Chief of Police, or their designee(s) proof of qualification for such exemption.

O. Chapter 8, Article XIII, Section 8-414 of the *Municipal Code of the City of Hoover, Alabama* is hereby amended by adding the following:

**Section 8-414. Violations and Penalties.**

Any violation of any of the provisions of this Article shall be treated as an offense against the City and shall, upon conviction, be punishable as set forth in Chapter 1, Section 1-5 of this Code.

---

**Section 2. ORDINANCES REPEALED.** All other ordinances or parts of ordinances in conflict herewith are also hereby repealed.

**Section 3. SEVERABILITY.** That if any section, subsection, sentence, clause or phrase of this ordinance is, for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance. The City of Hoover hereby declares that it would have passed this ordinance, and each section, subsection, clause or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrases be declared unconstitutional.

**Section 4. LEGAL RIGHTS NOT IMPAIRED.** That nothing in this Ordinance or in the Code hereby adopted shall be construed to affect any suit or proceeding impending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed as cited in Section 4 of this Ordinance; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this ordinance.

**Section 5. PUBLICATION OF ORDINANCE.** That the City Clerk of the City of Hoover is hereby ordered and directed to cause this ordinance to be published and that a copy of this Ordinance be entered upon the minutes of the meeting of the City Council.

**Section 6. EFFECTIVE DATE OF ORDINANCE.** That this Ordinance and the rules, regulations, provisions, requirements, orders and matters established and adopted hereby shall be in full force and effect after its adoption and publication on June 13, 2016 and shall continue in full force and effect from month to month and year to year from its effective date until repealed.

THEREFORE, BE IT ORDAINED, that the City Council of the City of Hoover does hereby enact the foregoing Ordinance for the City of Hoover.


